#1 Per Event License

Contract #1 is for the right to display the DVD for one time use during your next event. #2 Merchant License

Contract #2 is for business' that are interested in using our DVD for in-house commercial display. The cost is \$1,500 per year, which comes with 24 DVD's that can be resold or gifted. The DVD usually retails for \$24.95.

#3 Custom License

Centered Films retains the rights to the footage but you will have your own branded video in no time at all considering the costs required to produce such a video on your own.
